## CERTIFICATE OF COMPLIANCE – RoHS3 1-23-2024 & REACH 6-27-2024 Declaration

BrainPad components and their homogeneous sub-components manufactured under the Lead-Free Program are in compliance with EU Directive 2011/65/EU(RoHS2Directive) & European Union Directive 2015/863 (RoHS3 Directive) of the European Parliament and of the Council of 22 July 2021 and all subsequent amendments. All BrainPad's parts have been identified as RoHS compliant and do not exceed the maximum limit for the following 11 designated substances.

**REACH** requires article suppliers to inform recipients if an article contains a Substance of Very High Concern (SVHC) in excess of 0.1% by weight.

The ECHA announced on **June 27<sup>rd</sup>, 2024** an updated list of the candidate **241** SVHC chemicals. Based on the material content certifications provided by BrainPad suppliers, none of these substances are present in the materials we use in our products, including packing and shipping materials. Therefore, BrainPad products do not contain any of these SVHC in excess of 0.1% by weight.

**REACH Annex XVII**. On September 27th, OJEU published Regulation (EU) 2023/2055 introducing a restriction on microplastics amending Annex XVII to (EC) 1907/2006, Article 33. BrainPad does not contain any of the restricted substances covered by the regulation.

**Substances of Concern (SCIP)** Directive 2008/98/EC, amended by Directive (EU) 2018/851. GHI Electronics does not contain any of the restricted substances covered by the regulation.

BrainPad will continue to comply with **REACH** requirements and notify customers of any change in article content. Our statements in this letter regarding **ROHS**, **REACH** compliance and lead content do not extend to, or apply to any product subjected to unintended contamination, misuse, neglect, accident, improper installation, or to use in violation of instructions

BrainPad 's sole liability for incorrectly certifying a product shall be either replacement of the BrainPad product or, alternatively and in the sole discretion of BrainPad, return of the purchase price paid for the relevant BrainPad product.
